The Vinto Metallurgical Company, in its capacity as a strategic company of the Plurinational State of Bolivia, has as its main activity the smelting and refining of tin concentrates from mining companies of the Plurinational State of Bolivia, state or private cooperatives and marketing companies that are legally established, aligned with the standards contained in this document and those established to ensure the supply chain.

The Vinto Metallurgical Company in compliance with the code of ethics (point 3- Commitment of the Vinto Metallurgical Company with our stakeholders, Point 4- Bribery and/or Extortion, Point 5- Political Activity, Point 6- Money Laundering, Point 7 - Conflicts of interest and Commercial opportunities), establishes the following mandatory compliance criteria in respect of Bolivian Laws, Annex II of the OECD Due Diligence Guide for Responsible Supply Chains of Minerals from Conflict Areas or High Risk Third Edition, and the Dodd Frank Act .

The Vinto Metallurgical Company is regulated in accordance with the principles, guidelines and procedures dictated by the Mining and Metallurgy Law of the Plurinational State of Bolivia Law 535 in force since May 28, 2014.

The Vinto Metallurgical Company does not have business with tin ore suppliers outside Bolivian territory and therefore does not do business with third parties associated in high-risk countries and conflict zones, nor with local companies that may import tin ores.

The Vinto Metallurgical Company maintains within its Code of Conduct policies of respect for Human Rights and does not tolerate for any reason nor will it obtain benefits and will never act to contribute, help or facilitate any actor to commit:

- 1.- Any form of torture or cruel, inhuman or degrading treatment
- 2.- Any form of forced labor or services demanded under threat
- 3.- The worst forms of child labor
- 4.- Other serious human rights violations and abuses such as widespread sexual violence
- 5.- War crimes or other serious violations of international humanitarian law, crimes against humanity or genocide

Extending to clients or suppliers. If we learn that these universal principles are being transgressed, our organization will consequently suspend any contract and commercial relationship with its suppliers or clients within the supply chain and will be subjected to an investigation process that will allow the transgression to be evidenced or not.

The Vinto Metallurgical Company negotiates under principles of honesty, rectitude and respect with our concentrate suppliers, in order to above all achieve their loyalty and trust towards our company with a fluid, timely and truthful information channel. Our premise is to provide certainty at all times to our suppliers, as well as ensure long-term sustainable supply.
